### **contract term**

A deposit of the bride's total balance \$ \_\_\_\_\_ is required to reserve wedding date. This is non-refundable.

The remaining balance payment can be paid by cash or credit card and can be taken at the time of your trial session. Due to the nature of the business your wedding date will not be held until a deposit is paid and a contract is received.

Your deposit will be deducted from the wedding day balance, which will be due on your wedding day. Please inform bridesmaids and family getting makeup on the wedding day the accepted forms of payment. (\*We require **\$300.00 minimum** services as a booking requirement. A credit card is required to ensure you will fulfill the minimum booking requirements. The credit card will only be charged if the minimum has not been met on or by the wedding day.

### **photo release agreement**

### **cancellation policy**

Deposits are non-refundable. Cancellations can be made up to 30 days before the wedding day without any extra charges. Your 50% original deposit is still non-refundable. If you cancel less than 30 days prior to your wedding date listed above, the 100% of total will be charged.
